Dear Blazer Parent,

As 2016 comes to a close, the Bethesda Academy admissions office is already making exciting plans for the upcoming school year. In efforts to properly plan and prepare for the upcoming academic year, we must know your commitment decision for your son's future 2017-2018 placement as a Bethesda Academy Blazer.

The Bethesda Academy re-enrollment application will be available on Tuesday, January 17, 2017. You may access the application by logging into your ren web account under the 'family information' tab. All parents planning for their student to return in the fall of 2017, must complete the re-enrollment application and satisfy the \$100 re-enrollment fee to guarantee student placement before Friday, February 17, 2017. As cottage availability is limited, eligibility requirements for boarding enrollment include parent's 3 consecutive months "good standing" tuition, student's overall academic performance and behavior. Applications for the boarding program will be evaluated first come, first served and will allow rising seniors first priority.

The deadline for the FACTS financial aid application and 2016 W2 and 1040 is April 7, 2017. All applications submitted after this date will be assessed a \$25 late fee. If your 2016 tax documents are unavailable before this deadline, you may attach a copy of your 2015 tax documents as an alternative option.


Bethesda Academy 2017-2018 financial aid award letters will be mailed beginning April 1, 2017 and must be signed and returned to the admissions office no later than Monday, **May 1, 2017**. Students with any outstanding balances or past due tuition accounts are ineligible for financial aid until all current financial obligations are resolved. - 2016-2017 financial aid awards will be mailed beginning May 1, 2016. Please sign and return your re-enrollment packet within 5 days of your receipt.
- No tuition payments will be withdrawn from your account until we have received a signed financial aid award letter stating that you agree to the new terms and conditions of your 2016-2017 tuition.
- You will receive an email from FACTS prior to the date of your first payment as a reminder.


You must now complete the Payment Plan setup in the FACTS system.

**Please note:** There are multiple steps in the Payment Plan signup process. After you have reviewed and authorized the selected payment plan, you will be automatically returned to Online Enrollment to finish any remaining forms within the packet.
